
- 1. Click on the iOS version or go directly to the official market (Apple Store) and search for "MotoGP Med".

- 2. Download and install as usual.





To access the app, use the information provided in the email – see above – to log in (Identifier and Password).




Once access details have been entered, the user must accept the legal conditions and the contingency plan applicable to this event. The terms and conditions contain a link to the contingency plan.





Once the Identifier and the Password have been verified and accepted, access via Touch ID can be activated on the device.





PRE-EXISTING CONDITIONS:

Once a user has accessed the app for the first time, they will receive an email to their personal account containing a form that must be filled in, detailing any pre-existing conditions that must be considered due to Covid-19. The objective of receiving this information is to make it available to the Medical Commission in order to better monitor any participants.

Vulnerabilities

- Cardiovascular disease, including hypertension
- Chronic lung disease (COPD)
- Diabetes
- Chronic renal insufficiency
- Immunosuppression
- Cancer in active treatment phase
- Severe chronic liver disease
- Chronic neurological or neuromuscular disease
- Morbid obesity (BMI> 40)
- Pregnancy
- Postpartum (<6 months)
- Over 65 years









Tab buttons for HOME, APPOINTMENTS, DOCUMENTS and PROFILE are always visible.



QR ACCESS CARD (FOR CIRCUIT ACCESS):



In the *QR Access Card* section the user will find their latest results for tests. These results will generate a QR code that will either grant or deny access to the circuit.



The user can also navigate to the contingency plan, past results and other options on the app from here.



VALIDATION PROCESS FOR MEDICAL RESULTS

In order to generate the QR code for circuit Access, the user should send the results obtained from their lab to the following email: infoMotoGP@quironprevencion.com

In order to ensure quick validation, the results should be sent between 9:00 and 15:00 CEST. The validation service is also available during the weekend preceding the GP. Results sent outside this timetable will be validated the following day.

As well as the stamp and signature of the laboratory in question, the official document containing the Covid-19 test results should include the following information in English:

NAME AND SURNAME OF THE PARTICIPANT

PASSPORT NUMBER (DNI/NIE for Spanish citizens)*

*If the lab cannot add this data to their document, the user must put it in the body of the email.

For users who have had their tests in *Quiron centers* and other approved labs working with MotoGP, reception and validation of the results in the APP will be automatic.




TEST HISTORY:

CONTINGENCY PLAN:




The section containing the Contingency Plan for the event in question will be accessible at all times. Any update to the document will be available instantly in this section.






COMMUNICATE YOUR SYMPTOMS:



In this section, the user can declare to the Medical Commission any symptoms related to Covid-19.

In order to assess your situation and to protect yourself and those around you, inform us if you have experienced or are experiencing any of the following symptoms in recent days:

- Fever >37.5
- Persistent cough
- Dificulty breathing
- Chest or throat pain
- Loss of smell or taste
- Diarrhea
- Abdominal pain
- Asthenia
- Anorexy



The user can fill the field with the symptom(s) from which they are suffering so that the Medical Commission can get in touch with them.

The user should put their phone number where indicated, including the country code.

If at the hotel, user will stay at his room waiting to be contacted by the MotoGP doctor. If at the Circuit, please stay in your working area isolated waiting for medical services to bring you to the triage zone.










This section will show appointments from official laboratories working with MotoGP.

This is divided in two sections:


- 1. MY HEALTH section shows predefined documents (user manual, FAQs ...) and your medical examinations with the test results that have been already validated by the medical commission.

How can you send documents to the medical commission automatically?

There is a "+" button to select the document available at documents section. You will find a display asking file, type of file and the creation date.

Click on "SELECT FILE", select your document (only PDF or JPG with a maximum size of 5 MB) and then click "SAVE".










This displays the details of the user. None of these details can be modified within this section.
